PROGRAMS AND MEMBER SERVICES

Much of the work of the Medical Society is done through its committees that tackle issues affecting physician practices. Many of the committees also provide opportunities for professional growth, responsibility, and outreach. Members are encouraged to become involved in their areas of interest and work to make the medical profession better as a whole. The Society values all members and provides a place for every physician regardless of their practice type, specialty, or location.

POLICY AND ADVOCACY SUPPORT

NMMS is committed to assisting and improving physicians' ability to practice medicine and accomplishes many of those goals through its legislative and lobbying activities. Briefing papers are provided to help members visit with their legislators on key issues prior to the start of the legislative session. Some recent advocacy efforts include:

- HB2 (2024): Increase of Medicaid Rates to 100-150% of Medicare Rates
- SB135 (2024): Addition of certain medical conditions for which step therapy and prior authorization cannot be imposed
- HB209 (2023): Increase of amount, number of years, and extension to all specialties for education loan repayment
- HB547 (2023): Provides GRT deduction for Copays and Deductibles
- SB7 (2023): Rural Health Care Delivery Fund
- SB232 (2023): Tightens credentialing timeline
- SB523 (2023): Establishes Independent Outpatient Health Care Facility as entity type under MMA with \$1M cap
- HB 11 (2021 Special Session): Amendments to MMA
- Cs/SB188 (2019): Prior Authorization Act
- Cs/SB337 (2019): Surprise Billing Protection Act
- SB11 (2018): Expedited guidelines for Step Therapy
- SB82 (2017): Removal of non-compete clauses in physician employment contracts
- HB270 (2016) Allow access to out-of-state healthcare for New Mexicans

The work of the Medical Society's committees is reported at the quarterly Council meetings and annual membership conference. Member issues that are not addressed by a standing committee may be presented at the quarterly Council meeting. Ongoing communication also includes:

- Electronic communications (weekly newsletter and "Our Voice for Medicine"), to include legislative briefs, updates on bills NMMS tracks, surveys, notices on key issues (e.g. credentialing, prior authorizations, Medicaid, Medicare, etc.) for your practices.
- "Noon-Zoom" online educational series offered twice monthly on practice and professional topics.
